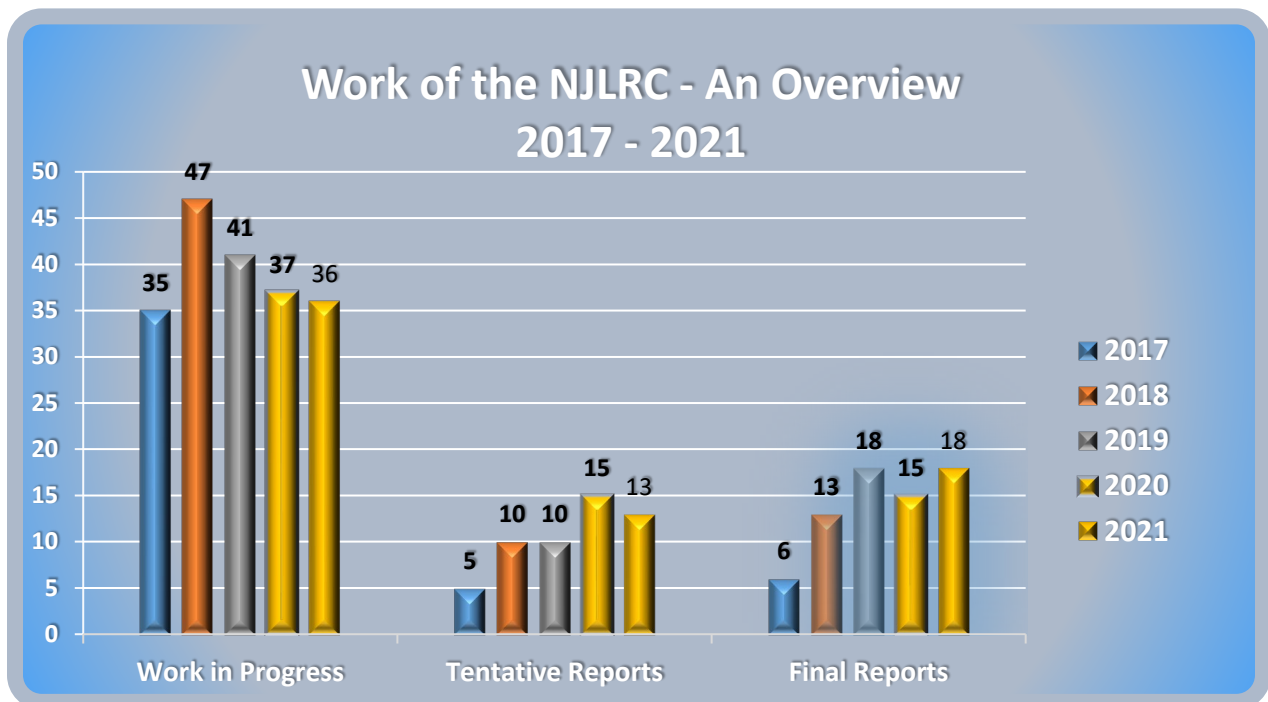

Bills

Bills introduced so far this session based on the work of the NJLRC include:

- S1195 – (Vitale) Revises the statutes concerning oaths and affidavits
- S1225 – (Greenstein) Concerns the mandatory refund of taxes paid in error
- S1548 – (Greenstein) Provides maximum workers' compensation regardless of outside employment
- S1606 – (Greenstein) Concerns unemployment benefits when offer rescinded
- A623 – (Kean, S) Establishes time periods for adverse possession of certain property
- A1314 – (Greenwald, McKnight, Park, Dancer) Concerns the mandatory refund of taxes paid in error
- A1315 – (Greenwald) Provides maximum workers' compensation regardless of outside employment
- A1316 – (Greenwald, Mukherji, Murphy) Concerns unemployment benefits when offer rescinded
- A2351 – (Mukherji) Concerns equitable distribution if one party to divorce or dissolution action dies prior to final judgment
- A2643 – (Dancer) Removes reference to kissing bible
